AFFIDAVIT IN SUPPORT

I KIIRA BRIAN ALEX, of c/o ALP Advocates, Lotis Towers, 5th Floor, Plot 16 Mackinnon Road, P.O. Box 28611 Kampala, do solemnly swear or (affirm) as hereunder;

- 1. THAT I am a male adult Ugandan of sound mind, the Program Officer, Business and Human Rights, Initiative for Social and Economic Rights (hereinafter referred to as 'ISER'), the 1st Applicant herein, and I affirm this affidavit in that capacity.
- 2. THAT the 1st Applicant is a local independent, not-for-profit human rights Non-Governmental Organisation (NGO) registered under the laws of Uganda whose objective is to promote the effective understanding, monitoring, implementation, and realization of Economic and Social rights in Uganda. [The Certificate of Registration of the Applicant is attached and marked "A-1"].
- 3. THAT the 1st Applicant fulfils its objectives on promotion of the Economic Social Rights including the Right to health and social protection as stipulated in domestic, regional and international human rights instruments through a combination of legal advocacy, strategic litigation, action-oriented research, monitoring and documentation; public information; capacity building; and community outreach, sensitization and empowerment.
- 4. THAT the 1st Applicant also engages in legal advocacy at a regional and international level. At the regional and international level, the Applicant has observer status with the African Commission on Human and Peoples' Rights (African Commission) and the African Committee of Experts on the Rights and Welfare of the Child (ACERWC); which mandates allow for it to monitor the implementation of economic and social rights under the African Charter on Human and Peoples' Rights (ACHPR) and African Charter on the Rights and Welfare of the Child (ACRWC) including the Right to health and Social Protection.
- 5. The 1st Applicant has also been active in monitoring the right to health and social protection in Uganda and reporting to international mechanisms including the Universal Periodic Review (UPR). In 2021, the applicant coordinated the preparation and drafting of the Civil

Society Organizations (CSOs) Alternative Report for the Universal Periodic Review (UPR) on the status of implementation of economic and social rights including the Right to health and social protection.

- 6. That the 1st Applicant has played a notable and influential role in monitoring, examining and studying the use of Uganda's National ID system in Uganda from 2019 to 2022, and undertook a joint in-depth qualitative research on the impact of this national ID system on the human rights to health and social security for women and older persons and developed a report based on research undertaken between November 2020 and May 2021 [Attached is the Report titled "Chased Away and Left to Die" marked "AA"],
- 7. The research focused primarily on the human rights impact of requiring National Identity Card, Number, or Register for access to health care and social benefit programs, and more specifically how this requirement, with its basis in the 2015 Registration of Persons Act (ROPA), affected women and older persons living in extreme poverty.
- 8. That in 2014, Uganda commenced the national ID card project with a mass enrolment exercise which sought to collect the biographic and biometric information of all adult's citizens. [See Neema Iyer, <u>Digital Identity in Uganda: Case Study Conducted as Part of a Ten-country exploration of Socio-digital ID Systems in Parts of Africa, 2021 accessed at <a href="https://www.africaportal.org/publications/digital-identity-uganda-case-study-conducted-part-ten-country-exploration-socio-digital-id-systems-parts-africa/last accessed 22nd April 2022]</u>
- 9. That previously, Ugandans relied on a wide variety of functional IDs, such as Voter's ID cards, drivers' licenses baptism cards, graduated tax slips, and letters from the LC1 Chairperson; refugees were issued cards through a partnership between the Ugandan Office of the Prime Minister and the United Nations High Commission for Refugees (UNHCR).
- 10. That the National Identification and Registration Authority (NIRA) issued two credentials—the National ID Card (NIC) and the National ID Number (NIN)—and also built a central database, the National Identification Register (NIR) and long after the initial mass registration, people in Uganda continue to interact with NIRA to register; collect cards; replace lost, stolen, or damaged IDs; and correct errors.
- 11. Today, those who missed out on a mass registration drive must either travel to registration points at NIRA's newly established district offices (currently in 117 out of 146 districts in Uganda) or to NIRA headquarters in the capital of Kampala. Otherwise, they must wait until NIRA conducts one of its irregular mop-up drives—onetime registration or issuance exercises where NIRA staff travel to local communities to try and enrol those who have not yet signed up or to issue cards that have been printed. [Attached is the Statement to Parliament on the Decentralisation of NIRA Services, March 2020 marked "A-2"].
- 12. That there is little flexibility in when and where individuals could come and register because they had to wait for NIRA to visit an accessible location. The process often required returning to the registration point multiple times, sometimes five or six days in a

- row due to limited registration officers or sound equipment to serve the long queues. Repeated travel meant that individuals needed to incur significant costs and were unable to engage in normal livelihood activities for periods of time.
- 13. That by establishing few registration points, accommodations for those who were elderly, sick, disabled, or had limited mobility are insufficient. Difficulties registering are also common among those who were illiterate or not able to understand the registration forms, which were available only in English, requiring additional costs.
- 14. During the registration process, many had difficulty submitting their biometric information, in the form of fingerprint scans and facial photographs. Others were not able to provide sufficient documentation, such as birth certificates or baptism certificates, in order to register.
- 15. That the processing of data by NIRA and the verification of citizenship has led to significant delays, and that many who attempted to register have still not received a NIN or NIC despite having submitted their information. Members of certain tribal groups, including the Maragoli, and those unable to provide sufficient documentation have also been unable to complete the registration process. Since individual information is held centrally by NIRA, it is difficult for these individuals to determine the status of their registration unless they are able to travel to Kampala. [Attached is the Report of the Auditor General on the Financial Statements of the National Identification and Registration Authority for the Year Ended 30th June 2019 marked "A-3"].
- 16. As at 2019, only 12.7 million cards had been issued according to an audit of NIRA's accounts by the Office of the Auditor General. [Attached is the Auditor General's Value for Money Audit Report on the Identification and Registration of Persons by the National Identification and Registration Authority (NIRA), 2018 marked "A-4"].
- 17. That based on an adult population of about 18.9 million people in 2019, using national population projections by the Uganda Bureau of Statistics (UBOS), this means that only 67% of the adult population had a National Identity Card in 2019, leaving 33% of Ugandans without a National Identity Card.
- 18. That the Minister of Internal Affairs released figures to the effect that National Identification Regulatory Authority had printed 18.32 million cards as of March 2020, and of those, only 15.23 million had actually been issued. As a result, assuming an adult population that Uganda Bureau of Statistics projected to reach 19.7 million in 2020, this means that at least 23% of Ugandans were without a National Identity Card. This figure does not include those who have significant errors in their particulars, or those whose card has been lost or stolen. - 19. While NIRA offered guidance on how to estimate an individual's age using historical events, many older persons report that the younger officials were not familiar with local history (and often did not appear interested in achieving accuracy). As a result, errors in respect to age, especially of older persons have been reported and impeded access to social protection.
- 20. The Ministry of Gender, Labour and Social Development (MGLSD) is mandated to promote and protect the rights of older persons in Uganda. In 2010, MGLSD began piloting the Expanding Social Protection Programme (ESP) with the support of Irish Aid, DFID, and UNICEF.
- 21. That Uganda's National Policy for Older Persons, 2009, sets out the guiding principles of equal treatment, social inclusion and the provision of livelihood support for older persons. It further identifies the provision of direct income support and social insurance as key social protection instruments for older persons. [Attached is the National Policy for Older Persons, 2009 marked "A-6"].
- 22. The SCG has been a popular and promising programme with impact evaluations suggesting that it brings about reductions in extreme poverty; increases household expenditure; improves children's educational attainment; improves food security, access to markets, and savings; and stimulates marketplaces. [Attached is the Quantitative Impact Evaluation of the SAGE programme marked "A-7"].
- 23. At the commencement of the program, data from Uganda Registration Services Bureau (URSB) was doing in partnership with UBOS to register births and deaths in the country was utilised. The URSB shared lists of potential beneficiaries with the SAGE programme staff who could then use these lists to identify all older people above a certain age threshold in each district it was working in.
- 24. That in addition, the programme made use of community targeting by facilitating meetings with Local Council (LC1) chairpersons to validate an older person's age. Everyone was asked to bring any form of ID they had, such as birth certificates, voter ID cards, or even baptism cards. In the absence of any form of ID, the LC1 would verify the age of the person using references to widely known local or historical events. The LC1 would then generate lists, and attach his or her signature, which would be submitted to local Community Development Officers, who in turn shared them with the SAGE programme management staff.
- 25. That in 2015, during the second phase of the ESP, the operating procedures of the Programme Management Unit (PMU) were restructured. This included automating the process of identifying eligible beneficiaries for the SCG and relying exclusively on data from NIRA's National Identification Register (NIR). [Attached is the Minister of Gender Labour and Social Development, "SAGE Operations Manual June 2016," June 2017 marked "A-8"].

- 26. That the PMU also verifies the identity of individual beneficiaries using the NIR data (before COVID-19) and fingerprint scanners at different points in the registration, enrolment, and payment process. Therefore, Older persons therefore must be included in the NIR, with accurate details, if they want to access the SCG. They sometimes must also biometrically authenticate using a fingerprint scanner. [Attached is the Statement on the National Roll Out of the Senior Citizens Grants Under the Social Assistance Grants for Empowerment marked "A-9"].
- 27. That participating in the SCG cash transfer programme now requires a triple registration process: first, registration with NIRA for a national ID; second, registration and enrolment with the ESP for the programme itself, which is only possible if the first registration has been completed; and third, registration with the payment service provider who will be issuing the actual cash. [Attached is the Response to Parliament on a Question Raised by Hon. Kamateeka Jovah on Verification and Enrolment of New Eligible Beneficiaries under the Social Assistance Grants for Empowerment (SAGE) marked "A-10"]
- 28. That Government of Uganda's policy through the Ministry of Health requiring presentation of a National Identity Card and / or National Identification Number to access to public health facilities and services has become a significant barrier to accessing health services to which individuals are entitled and leads to exclusion of some individuals who are unable to present their National Identity Cards or National Identity Numbers.
- 29. That subsequently, the Government of Uganda established the Expanding Social Protection (ESP) programme and introduced the Senior Citizens Grant (SCG) as part of the Social Assistance Grants for Empowerment (SAGE) scheme, followed subsequently by the official National Social Protection Policy, 2015. As a result, the Government through the Ministry of Gender Labour and Social Development pays a regular monthly pension of UGX 25,000 (approximately US\$ 6.70) per month to over 150,000 older persons in bimonthly instalments.
- 30. That when the Senior Citizens Grant (SCG) was first piloted, the majority of recipients did not hold identity cards as they were born at a time when there was no birth or Identity registration system in place and as a result had to register for the National identification for the first time in their lives in order to access SAGE grants.
- 31. That to become a new beneficiary of SAGE you must have completed the registration process for the national ID and have been successfully included in NIRA's National Identity Register (NIR). That the mandatory requirement of use of National Identity Cards or National Identification numbers to receive social protection services affects vulnerable people who have not enrolled on the National Identification Register.
- 32. That it was often those in the lowest wealth quintiles who were least likely to have a national ID. [Attached is the Committee on Defence and Internal Affairs, "Report of the Committee of Defence and Internal Affairs on the Registration of Persons Bill, 2014 (Including Minority Report) marked "A-11].

- 33. The State of Older Persons Report, 2020 highlights that over 60 per cent of persons aged 65 years and above in pilot districts of the SCG are receiving the pension, increasing to over 80 per cent benefiting in nine of the pilot districts. In contrast, coverage of SCG is much lower in roll-out districts, where the SCG is not universal, with less than 40 per cent of older persons reached in most of the districts and faces challenges including; difficulties in identifying and registering beneficiaries, timely and regular payments, and the accessibility of payment points for older persons [Attached is the State of Older Persons Report, 2020 marked "A-12"].
- 34. According to the State of Older Persons Report, 2020, the highest poverty rates are found among older persons aged above 75 years at 21 per cent. Almost 45 per cent of older persons live under the international extreme poverty line of US\$ 1.90 (PPP) per day, or UGX 2,700, whereas only less than 4 per cent older persons would be classified as 'non-poor', in other words living on at least US\$10 PPP and above per day—or UGX 13,700.
- 35. That the biometric verification through fingerprint scanners regularly fails and affects the rights of older persons who are beneficiaries under the SCG whose fingerprints have been worn away due to years of manual labour and have to travel to pay points to verify their identity and finger prints. This leads to painful scenes where frail older persons are literally carried to payment points to verify their fingerprints.
- 36. That by the Government of Uganda's reliance of the National identity system database as the single source "gospel truth" to confirm the beneficiaries of the SCG leads to violation of right to social protection and security.
- 37. That in 2019, the Ministry of Health (MOH) began announcing that the NIC would be a mandatory requirement to access any public health services, however strictly enforcing the national ID requirement would result in people being denied health care, including 'deserving' beneficiaries.
- 38. That local health workers and community officials rarely have access to equipment such as fingerprint scanners or card readers. For those who are rejected or chased, trying to access care often means spending money. This could involve the cost of traveling back and forth to the health centre, soliciting the LC1 Chairperson to travel with you to beg for access, or getting family members to bring you the necessary documents.
- 39. That the lack of accountability and redress mechanisms in registration for IDs is an impediment to the registration of persons and leads to violation of human rights. In Uganda An accountability mechanism specific to the National Identification system, as foreseen in Section 83 of ROPA, appears to be non-existent at present.
- 40. That whatever is stated hereinabove is true and correct to the best of my knowledge and belief save for paragraphs whose source of information is disclosed herein.

- 1. THAT I am a female adult Ugandan of sound mind, the Executive Director of Unwanted Witness (Hereinafter referred to as UW), the 2nd Applicant herein, and I swear this affidavit in that capacity.
- 2. THAT the 2nd Applicant is a local independent, not-for-profit human rights Civil Society registered under the laws of Uganda whose objectives are to inter alia; Contribute to entrenchment of effective, and efficient operational environment for enjoyment of human rights through highlighting the challenges facing human rights; Establish and promote initiatives necessary for effective advocacy in human rights through utilizing various media platforms; Encourage close collaboration and networking among human rights activists through opportunity creation, sharing forums and information exchange on human rights. [The Certificate of Registration of the Applicant is attached and marked "AB -1"].
- 3. THAT the 2nd Applicant executes its objectives through the effective and efficient use of the internet/ online activism, through networking, and strengthening capacities of citizens for collective Advocacy and Synergy.

- 4. THAT the 2nd Applicant has been following the evolution and development of the digital Identity system in Uganda since its inception and has conducted research, written legal opinions, reports and Briefs on Uganda's Digital ID to document its impact on the rights of Ugandans.
- 5. THAT in November 2020 and May 2021, the 2nd Applicant together with Digital Welfare State and Human Rights Project at the Center for Human Rights and Global Justice (CHRGJ) based at NYU School of Law in New York City, United States of America, and the Initiative for Social and Economic Rights (ISER) undertook research on the impacts mandatory requirement of the National IDs to access public welfare services and developed a comprehensive report named "Chased Away and Left to Die". (See copy of the research report is attached marked general annexure "AA")
- 6. THAT the research indicated that the mandatory requirement of National IDs has caused the severe exclusion of Ugandans especially women and the older persons to access Health and the Social Assistance Grant for Empowerment (SAGE) benefits respectively.
- 7. THAT the Uganda National Digital Identity System processes have deviances that impact greatly on the lives of Ugandans proportionately limiting the enjoyment of citizens' fundamental human rights which exacerbate the already existing inequalities in social and economic status among the majority poor population.
- 8. THAT the 2nd Applicant also conducted research that covered the areas of Kampala, Wakiso, and Kasese, where interviews were obtained from respondents who were above 18 years, to establish; the impact of the National ID system on the protection of fundamental human rights; and the impact of the National ID on citizen's enjoyment of services in Uganda.
- 9. That a report was developed and named "Uganda's Digital ID System: A cocktail of Discrimination", which indicated that 70% of the respondents said that they were required to present a National ID and 85% of these respondents were denied a public service for not having a National ID. (A copy of the report is attached hereto and marked "AB-2")
- 10. That I swear this Affidavit in support of an application for enforcement of enjoyment of the rights to health and the right to social protection for older persons.
- 11. That whatever is stated hereinabove is true and correct to the best of my knowledge and belief save for paragraphs whose source of information is disclosed herein.

AFFIDAVIT IN SUPPORT

I, ODUR ANTHONY of c/o, M/s ALP Advocates, Lotis Towers, 5th Floor, Plot 16 Mackinnon Road, Nakasero, P.O. Box 28611, Kampala, do solemnly swear and state as follows that:

- 1. THAT I am a male adult Ugandan of sound mind, a human rights lawyer passionate about health justice, and the Executive Director of the 3rd Applicant whose objective is to ensure that laws and policies are used as primary tools for the promotion and protection of health and human rights in Uganda, and do swear this affidavit in that capacity. (A copy of HEAPI's Certificate of Incorporation is attached and marked "OA 1")
- 2. THAT I am an active member of the Health and Disability Rights Working Groups of the Network of Public Interest Lawyers (NETPIL), School of Law, Makerere University; and a fellow working with the Centre for Strategic Litigation, (CSL), a Tanzania based not for profit organisation that seeks to advance the vision of a just and tolerant society, and a vibrant and inclusive democracy grounded in respect for the rule of Law and justice for all.
- 3. THAT I know that government is the primary provider of medical services for most individuals in Uganda and has approximately 3,133 public health facilities spread across the country. (A screenshot of Ministry of Health Hospital Information accessed on

20th April 2022 at https://www.health.go.ug/hospitals/) is attached hereto and marked "OA 2")

- 4. THAT by policy I also know that the Ministry of Health as per its Health Management Information System all patients are required to be identified by the National Identification Number (NIN) for the sole purpose of eliminating multiple issuance of same medications to same patients at different service points. (A copy of the Presentation on Integration of Services with the National Identification System, Uganda's case by the 2nd Respondent's Director Registrations and Operations delivered at the 3rd Annual Conference for the ID4Africa Movement Windhoek, Namibia April 2017 is attached hereto and marked "OA 3"; page 9)
- 5. THAT on the 11th March 2020, Government of Uganda through the Minister of State for Internal Affairs also reaffirmed the requirement of the physical National ID as a primary form of identification persons accessing the public services including health. (A Copy of the Addendum to the Statement made to Parliament On 3rd March 2020 on Statement to Parliament on Decentralization of NIRA Services is attached hereto and marked "OA 4"; See, page 4)
- 6. THAT I also know that the Auditor General on the 30th December, 2020 acknowledged that the delayed issuance of cards to the owners implied that they would not able to access a number of services including health that require an Identity card. (A copy of the Auditor General's Report on the Audit of Financial Statements of National Identification and Registration Authority for the Year Ended 30th June 2020 is attached hereto and marked "OA 5"; See, page 12)
- 7. THAT from the feedback I got from our community mobilizer Aryemo Anna and a regular user of Lira Regional Referral Hospital, I noted that patients with National IDs at the aforementioned facility are given priority over those without.
- 8. THAT as a lawyer who avidly advocates for increased access to healthcare services for the benefit of all persons, I know that the aforementioned practice of only considering patients in possession of National IDs is discriminatory and offends a bundle of rights that include the fundamental rights to life, health, equal treatment, and human dignity set out in the

- Ugandan constitution and the different International Human Rights Instruments for Uganda is signatory.
- 9. THAT I also know that Government has admitted that there are inherent challenges of the registration processes regarding National ID system which caused some of the older persons especially the frail and sick to miss out on being registered thus exacerbating inequity and inequality for those entitled to benefit from social protection programmes. (A copies of the State of Uganda Population Report 2019 and statement of the Minister of State for Elderly Affairs dated 17th February 2022 are respectively attached and marked "OA 6" & "OA 7" See: pages 49 & 3 respectively)
- 10. THAT in addition to the above, I also know that threat to insist and/or the insistence of the use of the National ID as the only source of identification inhibits the implementation of the progressive interventions for improving population health in addition to impeding the set target for increasing the proportion of the population accessing universal healthcare from 44% in 2018 to 60% as laid out in the Third National Development Plan (NDP III) 2020/21 2024/25. (A copy of the Third National Development Plan (NDP III) 2020/21 2024/25 is attached hereto and marked "OA 8"; See; pages 156 & 161)
- 11. THAT I also know the Government's failure to allow the use of other means and forms of identification in the promotion, respect and upholding of the rights to social protection of older persons under the SAGE Program and access to health services is contrary to the Constitutional mandate of the Respondents under Articles 8A, 20, 21, 22, 33 (1), 35 & 45 of the Constitution, and Objectives 7, 14 & 20 of the National Objectives and Directive Principles of State Policy.
- 12. THAT I know that the Government of Uganda through Ministry of Health (MoH) is duty bound under Objectives I(i), XI(i), XIV, & XX of National Objectives and Directive Principles of State Policy; and Articles 8A, 20, 21, 24, & 45 of the Constitution of the Republic of Uganda, 1995, as amended to ensure that all developmental efforts are directed at guaranteeing maximum social well-being of the people which includes facilitating direct provision of basic medical services without discrimination.
- 13. THAT it is interest of justice all the reliefs sought in this Application be granted.
- 14. THAT Whatever I have stated herein is true to the best of my knowledge and belief save for the paragraphs whose source of information is disclosed therein.

height examinations and speaking to a medical officer who then prescribes drugs to be taken in the course of the month.

- 5. THAT I have been observant that during the routine checkups at LIDC, Lira Regional Referral Hospital, nursing officers on duty call out patients to first present their National IDs and then forward their prescription and record book.
- 6. THAT on such occasions I have witnessed nurses considering patients with National IDs and attending to them first and asking those without to wait.
- 7. THAT I also know that the habit of conditioning persons living with HIV by nurses at Lira Regional Referral Hospital to wait for care services on account of not having National IDs exacerbates the existential stigma and discrimination.
- 8. THAT the aforementioned practice encourages persons living with HIV to disregard strict adherence to medication in addition to causing them to shy away from seeking medical attention for fear of being discriminated which in turn causes depression and uncalled for deaths among persons living with HIV.
- 9. THAT from the patients' rights trainings, I have received from facilitators 3rd Applicant, I know that the requirement to present National IDs impedes access to healthcare services for persons living HIV and as such violating their right to health contrary to Articles 8A, 20, 21, 22, & 45 of the Constitution, and Objective XX of the National Objectives and Directive Principles of State Policy.






